

PRIVACY POLICY FOR EXCURSION REGISTRATION FORM

INFORMATION PURSUANT TO ARTICLES 13-14 OF THE GDPR 2016/679 (GENERAL DATA PROTECTION REGULATION).

Dear Sir/Madam,

pursuant to article 13 of EU Regulation 2016/679 and in relation to the information that will be shared, for the purpose of protecting people and other subjects regarding the processing of personal data you are therefore informed of the following.

1. **Purpose of the Processing.** Data provided will be used for the following purposes:

1.a.) to hold the excursion organised by the Consorzio Turistico Limonese and for communications relating to the same excursion;

1.b) to sign up for the Consorzio Turistico Limonese newsletter to be able to receive advertising material and/or information on activities promoted by the same Consorzio.

2. **Processing Methods.** Personal data will be processed in paper and electronic form by the organisers for all the formalities connected to the excursion.

3. **Provision of data.** Provision of data for the purposes outlined in point 1.a) is mandatory and any refusal will make it impossible to accept registration for the same excursion. Provision of data for the purposes referred to in the aforementioned point 1.b) is optional.

4. **Communication and dissemination of data.** Data provided can be shared to the Municipality of Limone sul Garda and with cycling guides including mainly Mr. Tiziano Melzani, as subjects that collaborate with the Consorzio Turistico Limonese to organise excursions.

5. **Special categories of personal data.** Pursuant to articles 9 and 10 of EU Regulation no. 2016/679, you could provide the Consortium with data that can be qualified as “special categories of personal data” that is that reveals “*racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, as well as genetic data, biometric data intended to uniquely identify a natural person, data relating to health or sex life or sexual orientation of the person*”. These categories of data can only be processed with your free and explicit consent, expressed in writing at the bottom of this information.

6. **Data Controller.** The data controller in charge of processing personal data is Mr. Enrico Piantoni c/o Consorzio Turistico Limonese (VAT Code: 02629000981), with registered offices in Via IV Novembre no. 29/l- 25010 Limone sul Garda (BS)

7. **Rights of data subjects.** Pursuant to articles 15 and 22 of EU Regulation no.2016/679 you can exercise your right to the following at any time:

a) request confirmation of the existence of your personal data;

b) obtain information about the purposes of processing, categories of personal data, recipients or categories of recipients to whom the personal data has been or will be disclosed and where possible the envisaged period for which the personal data will be stored;

c) obtain rectification or erasure of personal data;

d) obtain the restriction of processing of personal data;

e) obtain data portability, i.e., receive a copy of the data in a structured format, commonly used and readable by an automatic device and transmit it to another data controller without impediment;

f) object to processing at any time even in the case of data used for direct marketing purposes;

g) object to automated decision-making processing relating to natural persons, including profiling;

h) ask the data controller for access to personal data or rectification or cancellation of the same or to limit processing relating to you or to object to processing as well as the right to data portability;

i) withdraw consent at any time without prejudice to the lawfulness of the processing based on the consent given before the revocation;

j) lodge a complaint with a supervisory authority.
