# NOTICE PURSUANT TO ARTICLE 13, EUROPEAN UNION REGULATION NO. 2016/679 (GENERAL DATA PROTECTION REGULATION – GDPR)

### 1. Methods of processing

#### 6. Transfer of data

The management and storage of Personal Data shall take place on servers located within the European Union. The data shall not be transferred outside the European Union. - to obtain: a) updating, rectification or, where there is an interest, the supplementation of data; b) the cancellation, anonymisation or blocking of data unlawfully processed, including data whose retention is not necessary for the purposes for which the data was collected or subsequently processed c) certification to the effect that the operations referred to in points a) and b) above have been brought to the attention, also with respect to the content, of the entities to which the data has been communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected;
- to object, in whole or in part: a) for legitimate reasons, to the processing of personal data concerning yourself, even if pertinent to the purpose of collection; b) to the processing of personal data concerning yourself for the purpose of sending advertising materials or direct marketing or for the performance of market research or commercial communications.
